

# I am requesting apology from Board of Trustees

In February-14 2020 Board of Trustees meeting, you fired me with an unanimous vote, and gave me 1 day notice to vacate my office and terminated my health-care coverage. A tenure professor almost never gets fired, unless there is an exceptional case of neglecting academic duties or committing crimes, which clearly does not apply to me. In that Board of Trustee meeting you made a FALSE claim that I did not teach my classes. On the contrary I did teach all my assigned classes with great success, more than required by my contractual agreement with MSU <https://selmanakbulut.com/uglymsustory.pdf>, Getting several subordinates and friends to write a fraudulent review report against the person you want to target, does not make your slanders true. This kind of behavior sounds too familiar doesn't it? My spotless teaching and grant records are in the university servers, they speak for themselves. President I am requesting you to correct your claim.

In your televised Board of Trustee meeting you made another FALSE claim that I threatened people with emails. I was appalled to see on WWMTV, Provost Teresa Sullivan making the statement "Professor akbulut attacked people with his emails" (a university officers should never slander a faculty reputation in a public form without proof!). After that meeting several news reporters requested my alleged offending emails from MSU (FOIA request) and they received it, I am attaching them to this document. Most of what your office sent were redacted by black ink, as if they were profanities. Of course I supplied the un-redacted originals to the reporters, as you see there are no threats nor attacks there, only appeals to university administration to correct my academic record that which was being smeared. President Stanley I request from you to show exactly WHICH email of mine is attacking anyone, which email of mine contains incorrect information?

If you behave like this how can we repair this broken system in MSU?

President Stanley while preaching transparency in public, you can not smear the reputation of a faculty, who dares to report corruption. I believe you owe me apology for slandering my reputation in public, in fact you should thank me for reporting serious wrongdoings in MSU. For a long time many MSU administrators have been shielding sexual and academic abusers and racist discriminators. It is this kind of behavior which keeps abusers in university protected, and brings humiliation to MSU. We need more reporting of misconduct not less! President Stanley and The honorable members of Board of Trustees did you know:

*The head of Faculty Grievance Office Bill Donohue whose job was to give me a grievance hearing (which I am entitled to) refused to do it. Did you know he himself was found to be responsible for sexual misconduct on three different occasions? (WKAR report). Do you know any other public university whose Grievance Committee is headed by an abuser? Did you know, despite knowing all these facts full well, without FGO Hearing report, your associate dean Terry Curry penalized me, with salary reduction anyway? Did you know provost June Youatt, who conducted my firing, was found to be responsible for shielding a convicted sex offender dean on campus? Did you know CNS dean Jim Kirkpatrick refused to meet with me even once, before sending me to Terry Curry's office to get penalized? Did you know CNS dean Phillip Duxbury who was supposed to make CNS's case against me in MSU court, did not even show up once in the court? Did you know math chair Keith Promislow, who initiated the slander campaign against me, ADMITTED lying and falsifying records in MSU court in order to penalize me? (he cried on the stand when confronted with facts). Did you know, for no reason, your administration attempted to impound my research funds which had been awarded to me by NSF (thanks to NSF and Harvard University's affords, the funds have now been rescued on behalf of me). My final question to you: "Why do you have so much hate and hostility towards me?"*
